## FIRST AMENDMENT TO CONDOMINIUM DECLARATION FOR ARTHAUS CONDOMINIUM

## **RECITALS**

- A. A Condominium Declaration for artHAUS Condominium (the "**Declaration**") was recorded at Recording No. 20150545214 in the records of the County Recorder of Maricopa County, Arizona, submitting certain real property described in the Declaration to a condominium pursuant to the Arizona Condominium Act, A.R.S. § 33-1201, et seq.
